SPECIAL UPDATE

Scholarship Program

The Scholarship Committee has been busy since July 2021 to update the vesting requirements and eligibility monetary amounts for people requesting scholarships. The changes are:

- Member vestment will be \$40 to qualify for up to \$1,500 (a \$500 increase over previous years) scholarship and a vestment of \$100 (an additional \$60 contribution to the scholarship fund) to qualify for an additional scholarship award from \$1,501 to \$3,000 (a \$1,000 increase over previous years.) No more than \$1,500 in any one year will be awarded. Effective dates for this change will be the 2022 scholarship requests. Each participant must have made this contribution before the end of the previous year's AM/PIC (2021.) Check with your State Scholarship Committee Chair to confirm this prior to applying (if one person within the group has not contributed \$40 by the deadline, it disqualifies the entire group).
- Member vestment will increase to \$100 to qualify for up to \$1,500 scholarship and \$200 (an additional \$100 contribution to the scholarship fund) to qualify for an additional scholarship award from \$1,501 to \$3,000 (no more than \$1,500 in any one year will be awarded). Effective dates for this change will be the 2023 scholarship requests. Each participant must have made this contribution before the end of the previous year's AM/PIC (2022.) Check with your State Scholarship Committee Chair to confirm this prior to applying (if one person within the group has not contributed \$100 by the deadline, it disqualifies the entire group).

Deadline for National Committees is **March 1st!** Check website for details!




